3.1 Presentation - O.P.P Detachment Board Transition

Mr. Wright spoke to the Community Safety and Policing Act, 2019 and noted the following legislation requirements:

Renfrew Police Services O.P.P. Detachment Board
By-Law Number 03-2024

Being a by-law to confirm the proceedings of the inaugural meeting of the Renfrew Police Services O.P.P Detachment Board dated May 3, 2024, and the regular scheduled meeting of the Renfrew Police Services O.P.P. Detachment Board dated June 20, 2024.

Whereas, Section 67 of the *Community Safety and Policing Act, 2019, S.O. 2019, c.1, Sched. 1*, provides that the powers of a OPP Detachment Board shall be exercised by its Board; and

Whereas, Section XX of the said *Community Safety and Policing Act* provides that the powers of every Board are to be exercised by by-law; and

Whereas, in many cases action which is taken or authorized to be taken by the Board does not lend itself to the passage of an individual by-law; and

Whereas, it is deemed expedient that the proceedings of the Board of Renfrew Police Services OPP Detachment at this meeting be confirmed and adopted by by-law.

Now Therefore the Board of the Renfrew Police Services O.P.P. Detachment Board enacts as follows:

1. That the actions of the Board in respect of each motion and resolution passed and other action taken by the Board at this meeting is hereby adopted and confirmed as if all such proceedings were expressly embodied in this by-law.
2. That the Chair and appropriate officials of the Renfrew Police Services O.P.P. Detachment Board are hereby authorized and directed to do all things necessary to give effect to the action of the Board of the Renfrew Police Services O.P.P Detachment Board referred to in the preceding section.
3. That unless otherwise provided, the Chair and Recording Secretary are hereby authorized and directed to execute all documents necessary.
4. That this by-law shall come into force and take effect upon the date of the final passing thereof.
